

**AMENDED FRANKLIN COUNTY WATER DISTRICT
NOTICE OF 2023 DIRECTOR ELECTION – PLACE 3, 4 AND AT-LARGE**

Notice is hereby given that Franklin County Water District (the “District”) will hold an election on May 6, 2023, between the hours of 7:00 a.m. and 7:00 p.m. for the purpose of electing three (3) directors for Place 3, 4 and At-Large who shall serve a four (4) year term.

There will appear on the ballots used in the election the names of the candidates for the office of director who filed applications to have their names printed on the ballot by February 17, 2023, at 5:00 p.m.


