

NOTE TO PRESIDING JUDGE:

The automatic tabulating equipment may not be used to count ballots voted in the election until the second test conducted under Section 127.093(c) is successful. If the initial second test is unsuccessful, the Presiding Judge of the Central Counting Station shall prepare a written record of the changes to the program, adjustments to the equipment, and other actions taken to achieve a successful second test. The record shall be retained with the test materials. When a test is successful, the Presiding Judge shall certify in writing that a test was successful and the date and hour the test was completed. The certification shall be retained with the test materials. [Sec. 127.097]
