FRANKLIN COUNTY PLAN OF ACTION IN EVENT OF DISASTER - ROBERT ZINN

Emergency Management Services Coordinator Robert Zinn reported there is a plan in place for a natural disaster in Franklin County. The Red Cross will set up a central location for people to come to get information. There is a need for an area to keep pets for people until they can find a place to live after a disaster. The storm shelter program be in place by June 1st. The Commissioners' were told during a disaster they will need to go to a central location and will be given directions. Two or three disaster drills needs to be performed a year.

FRANKLIN COUNTY ARTS ALLIANCE REQUEST TO REVISE LEASE AGREEMENT TO CREATE OLD JAIL INN – RON BARKER – Ron Barker requested revising the Lease Agreement to create an Old Jail Inn. Mr. Barker provided an estimate of \$40,000 to \$75,000 would be needed for renovations and projected revenues up to \$2,000 a month was possible. The Commissioners' had many questions that needed to be answered before another meeting could be held.

REVIEW COUNTY AUTO AND LIABILITY RENEWAL - TREASURER

Commissioners were asked to review the county auto and liability renewal and return by Monday. After discussion, it was decided to keep liability insurance.

DISCUSS COUNTY PICNIC - TREASURER

The county picnic was scheduled for June 15th at the Franklin County Airport and each elected official needed to donate \$50.00. People need to sign up to be a set up and cleanup crew.

SELECT DATE FOR 2018 BUDGET HEARINGS – AUDITOR

After discussion, the 2018 budget hearing will be scheduled after the auditor gets the numbers from the Appraisal District. Budget hearing will be scheduled if the numbers are lower than expected. The plan at this time is to keep the budget the same as 2017 budget.
