Items discussed:

- New Unfunded Mandate DPS required to start charging for forensic analysis services pursuant to Code of Criminal Procedure Article 38.35(c) Fees start on 9/1/2017 and Franklin County will incur some of these service costs in the FY2017 budget and these cost have not been included in the FY2017 budget. <u>Exhibit A & B</u>
- 2. DA / Probation budget increase from \$12,935 monthly to \$13,188 monthly. Auditor reported she anticipated the increase and built that into FY2017 budget. **Exhibit A**
- 3. Franklin County share of the FCAD 2018 budget (Sept to Aug) will be \$138,631 Exhibit A
- 4. Discussed tax rate / 2017 Budget Rate Worksheet Exhibit A & C
- 5. Discussed Investigator salary and a new vehicle / Discussed changing the way they are being paid / currently being paid with inmate housing funds
- 6. Sports Complex Judge to make contact with the Sports Associations to have discussion with them.
- 7. Discussed tractor and backhoe for waste management
- 8. Discussed Road and Bridge / not increase lateral road rate
- 9. Discussed using \$1,000 from inmate funds to start Active 911 for fire departments. This works through cell phones / frees up radio traffic / gives directions to incident / cost is \$11.27 per device per year. Commissioners requested putting this on the next agenda as an action item.
- 10. Discussed 50 cents per hour raise across the board
