 - (6) A current appraisal made in accordance with Texas Occupations Code, Chapter 1704.155(3).
 - (7) A sworn statement from Applicant's Spouse, if any, agreeing to transfer to the Franklin County Bail Bond Board, as part of the trust, any right, title, or interest that the Applicant's Spouse may have in the property, and that the Applicant's Spouse will execute deeds of trust to any community property placed in the security deposit.
 - (8) Documentation of insurance on the property listing the name of the insurance company to confirm that the property is properly insured. The insurance policy must show Franklin County Bail Bond Board as an additional insured.
