\*DO NOT RUN AD IN NEWSPAPER UNTIL AT LEAST 4 COPIES OF THE PLAT/REPLAT HAVE BEEN DEPOSITED WITH THE COUNTY CLERK. PLAT/REPLAT IS REQUIRED TO BE AVAILABLE FOR PUBLIC VIEWING ONCE AD IS RUN.
