Notice of Trustee's Sale

WHEREAS, the Declaration of Covenants, Conditions and Restrictions for Pine Valley Owners Association, Inc. a/k/a The Pine Valley Subdivision, executed by Double Diamond, Inc., as Declarant, and recorded on or about August 2, 1985, at Volume 189, Page 697, in the Real Property Records of Franklin County, Texas, including any amendments thereof, additions, annexations, and supplements thereto, and entitled "Covenants and Restrictions on and for The Pine Valley Subdivision" (the "Declaration"), designating The Pine Valley Owners Association, Inc. a/k/a The Pine Valley Subdivision (the "Association") to administer and enforce the Covenants and Restrictions contained in the Declaration, and providing for a lien against the individual lots located in the Subdivision to secure payment of assessments and related charges levied against the lots for common expenses;
