OPEN AND AWARD BIDS FOR REPAIR WORK AT FRANKLIN COUNTY AIRPORT -

JENNIFER JORDAN, FRANKLIN COUNTY AIRPORT BOARD - Jennifer Jordan with the Franklin County Airport Board was instructed a few months ago by Commissioners' Court to collect some proposals for repairs at the Franklin County Airport. She presented two proposals she had received for repair work from Hopco Millworks in the amount of \$20,167.41 and Steve's Construction in the amount of \$9,200. Commissioner Young made a motion to table this agenda item and suggested visiting the Franklin County Airport during the afternoon workshop session to discuss and prioritize items that needed to be done at the airport. Commissioner Surratt seconded the motion to table and the motion carried unanimously. It was also suggested to invite MMI (the company doing the restoration on the courthouse) to the meeting and hopefully they could assist with the process of prioritizing and make suggestions on what could be done to the windows and doors since there is a limited budget for the airport in 2014.

AUDITOR Commissioner Young made a motion to table this agenda item until some questions can be answered and hopefully get some wording changed in the last paragraph of the Order and Commissioner Surratt seconded the motion. Motion carried unanimously. The concern is the Order Authorizing the Creation of County Energy Transportation Reinvestment Zone (CETRZ) states "The Franklin County Energy Transportation Reinvestment Zone No. 1 shall remain in full force and effect for the initial term of ten years from the date of formation and shall terminate on December 31st of the tenth year after designation of the zone, unless extended by Order of the Commissioners' Court for an additional five year term." <u>COURTHOUSE RESTORATION</u> - Charlie Wilson with Komatsu reported the restoration project is moving along despite the weather and updated the court on the progress.

DISCUSSION ITEMS: Auditor Tina Phillips suggested calling TXDOT and to request them to not extend the CETRZ application period. Commissioner Young reported TXDOT is getting rid of equipment through a live auction. Sheriff Ricky Jones reported housing 30 Hopkins County inmates.

Commissioner Surratt made a motion to adjourn the meeting and Commissioner Young seconded the motion. Motion carried.
