CONSIDER AND TAKE ACTION ON INSTALLATION OF BURGLARY ALARMS AND PANIC ALARMS FOR COURTHOUSE BY C AND R SERVICES - TREASURER -

Ronald Rackley, owner of C and R Services reported the burglar and panic alarms will need to be upgraded one step because of the historic restoration that requires minimal wiring to be performed which will be concealed to the best of their ability. The total project price is \$3,800. Alarm monitoring is complimentary for the first year of service. Some questions arose concerning going out for bids. Commissioner Carr made a motion to approve the proposal from C and R Services in the amount of \$3,800 for burglar and panic alarms for the Courthouse. Commissioner Surratt seconded the motion. Motion carried 4 to 1 with Commissioner Chitsey opposing the approval.

<u>COURTHOUSE RESTORATION</u>. District Clerk Ellen Jaggers reported the court reporter table was not completed yet. She also reported a wasp problem in her office.

DISCUSSION ITEMS: Commissioner Carr reported the areas around Annex East building, County-Wide fire building east of town and the airport needed to be cleaned up. The workshop for the afternoon was cancelled since no other business needed to be discussed.

Commissioner Surratt made a motion to adjourn the meeting and Commissioner Young seconded the motion. Motion carried.
