## NOTICE OF PUBLIC HEARING ON TAX RATE

A tax rate of \$0.35228 per \$100 valuation has been proposed by the governing body of Franklin County.

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for Franklin County from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that Franklin County may adopt without holding an election to seek voter approval of the rate UNLESS the de minimis rate for Franklin County exceeds the voter approval tax rate for Franklin County.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Franklin County is not proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON AUGUST 26, 2024 AT 9:00 am AT Franklin County Courthouse, County Courtroom, 200 N. Kaufman, Mt. Vernon, Texas.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Franklin County is not required to hold an election at which voters may accept or reject the proposed tax rate, however, you may express your support for or opposition to the proposed tax rate by contacting the members of the Franklin County Commissioner's Court of Franklin County at their offices or by attending the public hearing mentioned above.

## **Indigent Health Care Compensation Expenditures**

Franklin County spent \$46,809 from July 1, 2023 to June 30, 2024 on indigent health care compensation expenditues at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$13,246. This increased the no-new-revenue maintenance and operations rate by \$0.00069/\$100.

## **Indigent Defense Compensation Expenditures**

Franklin County spent \$49,014 from July 1, 2023 to June, 30, 2024 to provide appointed counsel for indigent individuals in criminal or civil proceedings in accordance with the schedule of fees adopted under Article 26.05, Code of Criminal Procedure and to fund the operations of a public defender's office under Article 26.044, CCP, less the amount of any state grants received. For the current tax year, the amount of increase above last year's indigent defense compensation expenditures is \$569. This increased the no new revenue rate (NNR) maintenance and operations rate by \$0.00002/\$100.
